Subject: Resolution Number 40-2021

I am requesting support and approval for the acquisition of a 2021 Ford F-150 Police Responder patrol vehicle. This utility vehicle will allow the police department to have a diverse resource compared to traditional police vehicles. It will allow for responses to emergency management events, transport large evidence items, and will be high visibility for the City of Omak. This larger patrol vehicle will also accommodate officers of a larger frame. This vehicle will replace an obsolete Ford Crown Victoria. The Patrol Responder will be a metallic grey with the same markings as the Patrol Interceptor Utility.

Having the ability to assist in natural disasters, transporting a large amount of persons in the bed of the vehicle and hauling items that simply do not fit in a smaller patrol vehicle. It will also allow for towing of utility trailers for equipment. Through research of Okanogan County's purchase, it was found the King County Directors Association leveraged better purchasing power by eliminating un-necessary equipment selected on the state contract. This allows for an overall lower purchase than the 2020 and 2021 law enforcement Police Interceptor Utility vehicles. Upfit will be completed later by a selected vendor. The estimated cost with upfit is \$58,500.00.

In summary I want to thank you for your consideration for this much needed improvement in police operations.

A RESOLUTION OF THE OMAK CITY COUNCIL APPROVING A PURCHASE AGREEMENT WITH KING COUNTY DIRECTOR'S ASSOCIATION FOR PURCHASE OF A FORD POLICE RESPONDER F-150.

WHEREAS, the Police Chief has determined the need to replace an obsolete patrol vehicle; and

WHEREAS, the addition of a Ford F-150 Police Responder will add additional capabilities to the police department's resources; and

WHEREAS, the Police Chief has determined the availability of a larger patrol vehicle will aid in non-traditional response capacity; and

WHEREAS, the Department has evaluated different brands of equipment for operation, price, and serviceability; and

WHEREAS, the KCDA purchasing cooperative offers savings over state contract pricing; and

WHEREAS, the City of Omak entered into cooperative agreement with the King County Directors Association by Resolution 50-2010; and

WHEREAS, the Revised Code of Washington, Chapter 39.34 encourages the use of cooperative agreements to increase the efficiencies of local governments.

NOW, THEREFORE, BE IT RESOLVED BY THE OMAK CITY COUNCIL, that the purchase Agreement with KCDA, attached hereto as Exhibit "A", for the purchase of a 2021 Ford F-150 Police Responder, is hereby approved, and the mayor is authorized to effect all necessary action for the purchase of this equipment.

Subject: Resolution Number 41-2021

I am requesting support and approval for the acquisition of Lexipol Policy, Procedure, Implementation, and training program. This program suite will allow for improvement in best business practices for our Police Department. The program is currently being utilized by the Okanogan County Sheriff's Office, Brewster Police, Oroville Police, and Twisp Police. The program updates policies through review for each state. With the plethora of changes from the legislative intent of the legislature it is difficult to update all polices in a timely manner. This program allows for a trust bank of many disciplines who review best practice, law, case law, and trends in law enforcement and risk management. Due to our membership in the Cities Insurance Association of Washington and a member of Choose Clear risk management the City receives a 20 % discount and a \$2500.00 discount on Tier one implementation a 50% savings. Lexipol also offers a 15% discount when the Police One Learning Academy is purchased.

2021 Policy Manual and daily bulletins Cost \$2,571.96 8/1/2021 to 12/31/2021. Tier 1 implementation \$5,000.00, once implemented discounted to \$2,500.00 by Choose Clear. Police One Academy for 14 personnel \$1,071.00, setup fee \$300.00. The cost for 2021 is \$2,057.57 with 20% reduction, plus \$2,500.00 implementation, and \$1,371.00. Cost estimated to the City of Omak for 2021 at \$5,928.57. Each year after the cost will be estimated at \$7,243.70 (\$5,794.96 with 20% Choose Clear underwriting credit).

This program solution will greatly improve the efficiency, effectiveness, and best business practices of the Omak Police Department.

In summary I want to thank you for your consideration for this much needed improvement in police operations.
