

Re: Annexation of Okanogan County Parcel 3426340138

I am the owner of Parcel 3425340138 and I am requesting that this parcel be annexed to the City of Omak. This parcel consists of 5.73 acres bordered on the east side by Jasmine Street, on the south side by the property at 530 Jasmine Street belonging to Stephanie and Kenyon Sherwood and on the north side by the property at 406 Jasmine Street belonging to Ted Danielson. My property occupies approximately 470 feet of frontage on Jasmine Street. It is my understanding that the Sherwood property and the land south from there are currently within the City boundary.

This parcel is currently considered agricultural and is used as a pasture for horses. Due to the terrain and proximity to residential and business uses, this property is not well suited for agriculture but would be a good site for residential use and fit in well as a natural border to the city. It is my intention to develop this property with multiple residences. I recently had the county test the soil for sewage disposal which showed that it was suitable for on site sewage disposal though connection to the City sewage and water system would be desirable.



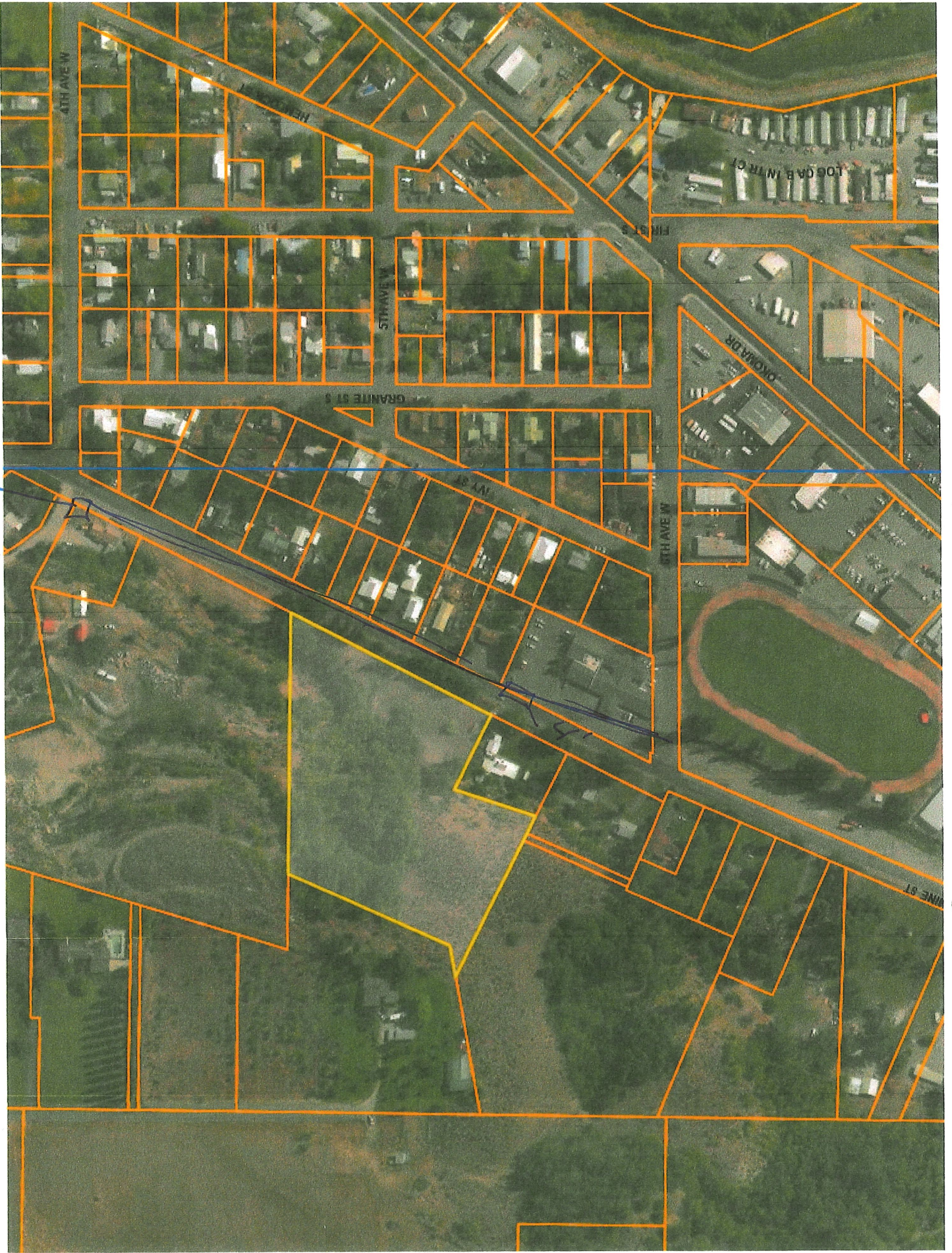

Subject: Resolution Number 01-2022

I am requesting support and approval for the acquisition of rifle parts to bring our Omak Police Department patrol rifles into compliance with RCW 10.116.040. Our patrol rifles were originally acquired through the Law Enforcement Officers Safety Act. Military grade M-16's were acquired legally through this process. Since this acquisition the state legislature changed the law and has made departments possession of military grade and machine guns illegal.

The Omak Police Officers Guild on their own last year acquired new uppers for the rifles at a cost of over \$10,000.00 and donated them to the Omak Police Department. What we are replacing is the lower half and upgrading with a company who issues the same rifle and will certify and guarantee the entire rifle with this upfit.

Firearms are very difficult to acquire, and this company has the parts available and the armorer to upfit the rifles on site. We currently are required to consider removing the rifles to comply with the law and this limits potential safety equipment for our officers and public.

This acquisition allows rapid re-deployment of the officers' safety equipment.

I recommend its approval and have the funds budgeted. Cost \$8,642.85.
