Subject: Ordinance 1937 Amending 2024 Budget, Street Fund - TIB Projects

The Attached <u>Ordinance 1937 Amending the City of Omak 2024 Budget,</u> <u>Appropriating Additional Expenditures and recognizing additional revenues in the Street Fund for 2024 Transportation Improvement Board Projects, is forwarded for your consideration.</u>

The city has received 3 competitive grants from the Transportation Improvement Board for: Central Avenue, Jonathan Avenue, and an area chipseal project. This Ordinance amends the Budget to recognize the anticipated revenues and expenditures that we will have this year.

The Central Avenue and Jonathan Projects are Design/Construction projects that will require additional appropriations in 2025. In total the TIB Award for the completion of these projects is \$1,794,134. The city will be required a match of 5%,

This ordinance recognizes \$295,361 in Revenue and appropriates \$279,462 in Expenditures for the Street Fund.

I approve this Ordinance and urge it Adoption.

ORDINANCE NO. <u>1937</u>

AN ORDINANCE AMENDING THE CITY OF OMAK 2024 BUDGET, APPROPRIATING ADDITIONAL EXPENDITURES AND RECOGNIZING ADDITIONAL REVENUES IN THE STREET FUND FOR 2024 TRANSPORTATION IMPROVEMENT BOARD PROJECTS

WHEREAS, the City of Omak adopted the 2024 Budget by passage of Ordinance No. 1931 on December 4, 2023; and

WHEREAS, the Washington State Transportation Improvement Board annually approves competitive grant funding to local jurisdictions at their December board meeting; and

- **WHEREAS**, as result of this board meeting, the City of Omak was selected to receive funding for three transportation improvement projects; and
- **WHEREAS**, to initiate these projects, it is now necessary to include the costs of these projects into the 2024 budget; and
- **WHEREAS**, the actual Beginning Fund Balances for fiscal year 2024 are now know; and
- **WHEREAS**, said expenditures are not one of the emergencies specifically enumerated in RCW 35A.33.080; and
- **WHEREAS**, the City of Omak is desirous of amending its budget pursuant to RCW 35A.33.090.

THE CITY COUNCIL OF THE CITY OF OMAK DO ORDAIN AS FOLLOWS:

- Section 1. Ordinance No. 1931 adopting the 2024 Budget, shall be amended to Include changes to the budget as shown in Attachment "A" of this ordinance.
- Section 2. This ordinance shall become effective from and after the date of its passage by Council by a vote of one more than the majority of all Councilmembers, approval by the Mayor and publication as required by law.

- **Section 2. Term.** Said appointment shall be from February 16, 2021 through February 16, 2024.
- <u>Section 3.</u> <u>Compensation.</u> Crandall shall be paid for his professional services at the rate of \$250.00 per hour. Crandall shall submit an itemized billing to City on a monthly basis with an itemization detailing the services performed and the time devoted to each case.
- <u>Section 4.</u> <u>Hearing Dates.</u> In concurrence with **Crandall**, **City** shall establish the time and date for monthly hearings before the Land Use Hearing Examiner.
- <u>Section 5.</u> <u>Relationship.</u> This Agreement is between the City and Crandall as an independent contractor. Crandall shall not be deemed an employee of the City. Crandall or City may, at their discretion, and without cause, terminate this contract upon 90 days advance written notice.
- <u>Section 6.</u> <u>Compliance With All Laws.</u> Crandall shall comply with all federal, state and local laws, rules, laws, regulations and ordinances applicable to the performance of this Contract.

Any actual potential conflict of interest shall be disclosed to all parties immediately upon the discovery of such conflict. Participants in the land use regulatory process have the right, in so far as possible, to have the Examiner free from personal interest or pre-hearing contacts on land use regulatory matters considered by the Examiner. If such personal or pre-hearing interest contact impairs Crandall's ability to act on the matter, he shall so state and shall abstain therefrom to the end that the proceeding is fair and has the appearance of fairness, unless all parties agree in writing to have the matter heard by said Examiner.

<u>Section 8.</u> <u>Assignment.</u> Crandall shall not assign or transfer any interest in this Contract without the prior written consent and approval of City.

<u>Section 9.</u> <u>Modification.</u> This contract may be amended, supplemented or otherwise modified by written agreement signed by all parties.

13.04.065 Commercial and for-profit use of parks.

The city recognizes there may be situations where it would be in the interest of the city and its citizens to allow use of city park property by organizations or companies that are proposing a for-profit event or facility. Such requests will be evaluated based on the expected benefits derived by development of a significant tourism event or facility or a cultural or commercial opportunity that would not otherwise be feasible in the community.

In such cases, the requestor will provide the following information:

- (a) Name of applicant;
- (b) Description of the event or facility;
- (c) Time period of the event or operation of the facility;
- (d) Expected attendance;
- (e) Description of the provisions for security which are approved by the city of Omak chief of police;
- (f) Plan for provisions for parking, restrooms, cleanup of the grounds, or any other additional provisions required and approved by the city of Omak director of public works;
- (g) Provisions for fire safety which are approved by the city of Omak fire chief;
- (h) Any other information that may be requested by the city to fully evaluate the request and make an informed decision.

This application needs to come to the city of Omak in a timely manner for scheduling of the park area.

Any alcohol sales require a special permit under Section <u>13.04.210</u>, approval by the Liquor Control Board and the Omak city council.

Upon receipt of an application submitted under this section of the code, the city council committee that is charged with park issues will meet with the applicant and staff to determine if the request is to be approved, and to set such conditions and requirements on the event or facility as are deemed appropriate. Any contract, concession agreement or special event agreement developed under this section must be approved by the city council by resolution. (Ord. 1777 § 4, 2014).
