According to my call, log 06/30/2024, 06/17/2024, I was inquiring if there was a law, rule or policy about public school buses driving on private roads.

The boss of the bus barn mentioned she was not aware of our private road.

My whole intentions of even communicating to the bus barn was to inform them that our road is breaking down, possibly due to the huge buses running on our private road, 2 to 4 times or more a day.

I emailed the bus barn 06/04/2024 also on 09/05/2024. Requesting rules, laws or policies about public buses driving on private roads.

On 09/05/2024 @ 4pm a speeding huge school bus did not make a full and drove into a huge pothole created at the corner of Omak River Road and Country View Road. (I have video)

I emailed Dan Payne about the situation. Which is included in my statement.

I also called and emailed Karin Mendez. She referred me back to Dan Payne.

Still hadn't heard from the school about anything of this matter.

10/09/2024 I was approached by some ladies from the Omak School District, that were escorted by Omak P. D.

The school could have called me. They could have emailed me. They could have sent a postal letter instead; they bring an officer to intimidate me.

Since, Omak PD was involved I requested public records on the situation on 10/11/2024. The report was finished10/09/2024. I got a copy on 10/15/2024.

After reading the report, I am furious that somebody would make these allegations against me.

When an officer is making a report, they are to take statements from all witnesses. No one got a hold of me for my statement and there is no statement from any other witnesses.

Omak PD and Omak School District had made claims that I was harassing disabled students.

I had mentioned in the past, this could be a potential civil process between the school district and our community about Clarifying The Rights of Our Private Property, as a whole, as a community.

The Omak PD and the Omak school district, have made allegations of me making threatening comments, which

is not the case and there is no proof of this. Where is it and who is it that is saying such a thing?

Anything that I have tried to communicated has been through email because it's very important that everything be documented.

I never once said anything about the front part of my property being destroyed. I have always mentioned that it's our whole community's private road, not just mine.

I have never made any comments about any disabled students.

Due to whoever is saying, these things that are untrue about me in the situation is faults. I would like to know who is claiming that. I never spoke anything about a child. I did mention that the Parents possibly did not want to walk a 1/2 a block to the bus stop.

Now, I am being accused of a hate crime against disabled children. If this was ever a case of a hate crime, it should have been reported to the prosecuting attorney. If there was a crime, then something should have been done immediately!

It's not about the children, it's about The People's Land Rights as a Community.

How dare anyone say I would harass a disabled student!

I have you know; I have a handicap granddaughter that cannot talk, walk, sit etc. and lives on a feeding tube.

SHAME ON YOU! Forever saying such a thing!

I complained to the school barn that they are driving on a private road and try to communicate with them on several occasions about the huge buses that are breaking down our whole community Private Road.

I speak a lot for our community about matters we have in our community about several different things like our Group A Well, safety and other topics, such as taking complaints, concerns and questions and speaking out against the bad things that have and are still going on in our community.

In conclusion, I would like to know who approved this report without talking to witnesses and providing proof of the allegations that you have set against to me?

Hello,

Your email was forwarded to me to help answer your question.

Washington State is a "local control state", which means that school districts are governed by a local elected board of directors. Many decisions are left up to that local school board and are not addressed in law or administrative rule enacted by the state.

Specific to your question, RCW 28A.160.010 which is linked below, states that the local school district board of directors is charged with the responsibility of determining the operation of the district's transportation system. They document those decisions in school board policy or procedure. The policy that you refer to was established by the Omak school board. They adopted that policy under the authority of RCW 28A.160.010. State law does not address whether a district should or should not / can or can not travel on private roads. I can tell you that many if not most school districts in the state have an identical policy. Travel on private roads that are not constructed or maintained to county road standards creates a liability for the district both in terms of safety of students riding the bus as well as the potential for damage to private property that the district could be liable for.

Your avenue of communication to have this policy considered for change would be the school board in Omak.

Hello and thank you for getting back to me.

I received this letter yesterday handed by school with a police Escort from the school Enforcement officer.

The chief of police will be talking to the officer because this is a civil suit pending.

I felt very intimidated.

They could have called me. They could have emailed me. They had my address and my name and they could have mailed me something. But instead, they brang the officer with them, to intimidate me.

I tried several times to email the school district. Nobody ever got back to me about the laws or the rules and in their own policy it says that they are not to go on private roads...

State law does not address whether a district should or should not can or cannot travel on private roads.

In the school's policy, 6600P Administrative procedure Page 1

L. Avoid travel on private roads drives, or property and on unimproved roads, (not sufficient to county Or city standards) or roads, which are in such bad condition as to cause damage to bus.

School districts in the state have an identical policy...

Travel on private roads that are not constructed or maintained to county. Road standards create liability for the district, both in the terms of safety of the students riding the bus as well as the potential for damage to private property that the district could be liable for.

Are city taxes and our county taxes? Do not pay for our private road.





#### **MANAGEMENT SUPPORT**

#### **TRANSPORTATION**

Routes should be established so as to:

- A. Avoid, whenever possible, left-hand turns when entering or exiting high-speed roadways.
- B. Avoid students crossing a four-lane road.
- C. Minimize stopping on multi-lane roads, unless the bus can get completely off the road.
- D. Avoid, is possible, crossing railroad tracks.
- E. Provide transportation to students who live within the distance specified for state funding from school or who would have to walk on a roadway declared unsafe by the board.
- F. Deliver students to their school no more than thirty (30) minutes before school starts. NOTE: It is desired that students arrive at school within five (5) to ten (10) minutes of starting time.
- G. Pick up students at school within five (5) minutes of dismissal, unless a delay is caused by a double run, or another guideline. In that case, students should be picked up within no more than thirty (30) minutes.
- H. Allow for a minimum "dead head" time between and to runs and no more than fifteen (15) minutes standby time between runs, provided that unless approved by the superintendent, all waiting time shall be on school property.
- I. Avoid travel on dead end roads, unless it is necessary within these guidelines and there is an ample, safe area in which a bus can turn around, without backing.
- J. Fill each bus to rated capacity, provided that it is economically feasible and within the other routing guidelines.
- K. Have minimum overlap or duplication in bus routes serving the same school.
- L. Avoid travel on private roads, drives or property and on unimproved roads (not surfaced to county/city standards) or roads which are in such bad condition as to cause damage to a bus.

#### **Bus Stop Guidelines**

Bus stops shall be established which:

- A. Are frequent enough so students do not have to walk more than one (1) mile to and from the bus. Bus stops may be more frequent when the road has been declared unsafe for walking.
- B. Are located where students can stand a safe distance from the road.
- C. Allow, where possible, the bus to get completely off the road.
- D. Provide at least 500 feet on 35-mile-per-hour roadways, and 800 feet on 50-mile-per-hour roadways of unobstructed visibility, both ways.
- E. Require as few students as possible to cross roadways with no students crossing multiple lane roads and highways.
- F. Are located where no damage is likely to occur to private property and where the number of students waiting does not create unsafe conditions and/or situations.

RE: School Bus Route Change for Special Needs Students

This letter formally addresses the recent changes and upcoming decisions regarding the school bus route serving special needs students in the Suncrest Trailer Park community.

To recap, a complaint was made in May of the 23/24 School Year addressed to the Omak School District and our Transportation Supervisor. This complaint stated that the bus was causing damage to the private roads within the Suncrest Trailer Park. The request was made to change the pick-up route for two special needs students from "at their door" to pick-up and drop-off to outside the park on Omak River Road.

In response to these concerns, the route was changed two days later to allow the district time to investigate the issues raised in the complaint further.

After extensive examination of this matter and careful consideration of the district's responsibility to adhere to Federal ADA (Americans with Disabilities Act) requirements, as well as local IEP (Individualized Education Program) and IDEA (Individuals with Disabilities Education Act) mandates, we are informing you of the following decision:

Effective October 10th, 2024, the district will be returning to the original route, which includes pick-up and drop-off at the doors of the special needs students within the Suncrest Trailer Park.

This decision has been made in consultation with our legal counsel to ensure compliance with all applicable laws and regulations and to meet the specific needs of our students as outlined in their IEPs.

We understand that this decision may raise concerns and are more than willing to discuss this matter further. If you wish to meet and discuss this decision in person, please get in touch with our office to schedule an appointment at the Omak School District Office at 509-826-8342 ext. 613.

We appreciate your understanding and cooperation in this matter as we work to provide the best possible educational experience for all our students while adhering to our legal obligations.

Narrative Section

On 10/09/2024 I assisted staff from the Omak School District in serving documents to R. M. JACKSON whom was identified as harassing disabled students and bus routes. I was informed that Omak School District staff would be serving documents stemming from an ongoing civil process involving alleged threatening comments made by JACKSON stemming from a bus route that goes in front of her residence within Okanogan County.

According to Omak School District Staff, JACKSON had complained that Omak SD buses would damage private roads in front of JACKSON's residence, additionally she had made comments about disabled students in disparaging terms. Should a victim be identified, the terms used by JACKSON would be identified as a hate

I informed the OCSO deputy on duty that I would be standing by while JACKSON was served these documents. I also informed my on-duty Sergeant for OMAK PD.

I was informed that Omak SD changed their bus route to accommodate JACKSON's complaints but after consulting with their attorneys, it was determined that the documents served were appropriate based on the American with Disabilities Act laws protecting disabled students.

At this time, there is no criminal investigation, however, OCSO is aware of the incident and bus routes affected by JACKSON's behavior understand that they must follow school protocols to report further violations, if any.
