On Wednesday, December 6, 2023, the City of Omak received 3 responsive bids for the Julia Maley Park Well Treatment. The responsive bids ranged from \$2,278,784.80 to \$2,840,220.92. The Engineer's Estimate was \$2,408,648.00. Each proposal was checked for correctness of extensions of the prices per unit and the total price. One correction was made; however, this correction did not change the position of the low bidder. We have provided a bid summary with this letter. The bidders and their respective bid amounts, including sales tax where applicable, are as follows:

The lowest responsive bidder, Rudnick & Sons, LLC of Okanogan, WA, is currently a Washington State registered and licensed contractor and appears to have the relevant qualifications and experience to successfully perform the work the project will require. To our knowledge, the lowest bidder has not claimed bid error and no formal bidding protests have been recorded. In accordance with RCW 39.04, we have verified the lowest bidder, Rudnick & Sons, LLC of Okanogan, WA, has met the responsibility criteria. The Mandatory Bidder Responsibility Checklist, including documentation, is attached for the City's file. We have also reviewed the Supplemental Bidder Criteria information submitted by Rudnick & Sons, LLC and they appear to meet the requirements of the Supplemental Bidder Responsibility Criteria.
