**City Utility Bills
Penalty Fee and Due Date**

The City would like to remind you about our utility billing due date. The bill is mailed out on the last working day of every month. By ordinance, your bill is due on or before the 15th. If your payment is not received in our office by the 25th of the month a penalty fee of \$20 will be assessed on the unpaid balance that next business day. As a utility customer, you have the responsibility to ensure your bill is paid on time. Nowadays, our customers have a variety of ways they can pay their bill. Cash or check at our counter is always welcome and it will give you peace of mind that your payment is made. The City also offers an online bill pay option at www.omakcity.com or pay by phone at 844-850-9187. In addition, your bank may offer online bill pay. For those customers who use the online banking services, please understand your funds do not go directly into our bank account. Your financial institution deducts the funds from your account and then, a physical check is generated and mailed to us. Depending on your bank and the US mail service, this process can take anywhere from 5-14 business days.
