MEMORANDUM OF AGREEMENT  
Fire District #3 Reimbursement to the City of Omak

THIS AGREEMENT, made and entered into this 18th day of June 2007, by and between the CITY OF OMAK, a municipal corporation of the State of Washington, hereinafter referred to as "CITY OF OMAK" and OKANOGAN COUNTY FIRE DISTRICT #3, an agency of Okanogan County, hereinafter referred to as the "FIRE DISTRICT".

WITNESSETH:

WHEREAS, the Omak Fire Chief is a full time employee for the CITY OF OMAK; and,

WHEREAS, the Omak Fire Chief responds to Fire District calls as well as performs other job duties for the Fire District; and,

WHEREAS, the Fire District is desirous of reimbursing the City of Omak for the Fire Chief's time in the amount of \$4,200.00 per year due on May 1<sup>st</sup> of each year; and,

WHEREAS, said amount will be reviewed from year to year to determine if said amount is in line with the time being spent on Fire District business.

NOW, THEREFORE IT IS AGREED BETWEEN THE PARTIES AS FOLLOWS:

- 1) The Fire District agrees to pay \$4,200.00 per year to the City of Omak for reimbursement of the Omak Fire Chief's time. Said payments are due on or before May 1<sup>st</sup> of each year, beginning in 2007 and retroactive to May 1, 2007. Said amount will be reviewed from year to year to determine if said amount is in line with time being spent on Fire District business.

NOW, THEREFORE, IN WITNESS WHEREOF, the parties have executed this agreement the day and year first above-written.
